## Other changes beginning Dec. 17

Please note the following changes as we make this transition listed below:

- Current blood product labels contain the statement "Neg for ZIKA by Investigational NAT." Products collected on or after Dec. 17, will no longer contain this statement.
- Blood products collected in states endemic for Babesia, currently have an attached tie tag which states "Neg for Babesia by investigational NAT." Beginning Dec. 17, <u>this statement appears on the product label</u>, thereby eliminating the attached tie tag.
- An <u>updated Circular of Information</u> will be distributed with product deliveries beginning Dec. 17, 2018.
