Quest Confirmatory Testing for Positive Barb or Benzo Screens:

Update on Drug Confirmation for Triage Kit (80306C)

- Effective May 15, 2017, there is no need to confirm positive Barb, Benzo, Coc, Opiate, THC and TCA urine drug screen results from **DRUG SCREEN, URINE, TRIAGE KIT [KPHC: 80306C/KRMS: 8410600]** except for children under the age of 14 years and pregnant women or when requested by the provider.
- All positive screen results for Amphetamine, Methamphetamine and PCP will continue to be automatically confirmed by another alternative method, without an additional order from the provider. Please send all positive screen results to SWL for confirmation.
- There will be no changes to the testing procedure.
- There are no changes to the LRR codes (KP Health Connect Codes)
- Urine drug screen results are for medical purposes, Chain-of-Custody is not monitored.

Tech:

- For all other confirmatory testing, release results, reprint label and take to Separations. Reflexed tests go to RRL. Cerner will reflex the confirmatory testing unless Cerner is down.
- For children under the age of 14 years and pregnant women or when requested by the provider (See above update):
 - Reprint patient's label and place below. Give form and urine specimen to accessioner. **DO NOT ALIQUOT SAMPLE.**
