Corewell Health East Laboratory Policy Addendum to Systemwide Policy – Attendance and Reliability

I. PURPOSE:

This document identifies a specific Corewell Health East (CHE) Laboratory policy that further defines the Systemwide Policy – Attendance and Reliability on the number of tardies and early outs.

II. POLICY STATEMENT:

It is the policy of CHE Laboratory to follow the written policies of Corewell Health. It is noted that further clarification and/or definition is, on occasion, needed for specific policies. Such a clarification is cited in this document.

III. DEFINITIONS:

Systemwide Policy – Attendance and Reliability definitions:

- A. **Tardy:** reporting to your shift up to six minutes after your scheduled shift start time.
- B. Early out: departing from your shift up to six minutes before your scheduled shift end time.

IV. PROCEDURE:

CHE Laboratory Clarification, January 1, 2024

Even though no occurrences will be issued for arrival between the scheduled shift start time and less than (<) six minutes after the scheduled shift start time (tardies), as well as leaving less than (<) six minutes before the scheduled shift end time (early out), a performance correction will be issued based

on the patterns of tardies, or early outs defined as follows:

- A. Ten tardies or early outs for the full time employed team members in a rolling three-month period.
- B. Six tardies or early outs for the part time and casual employed team members in a rolling three-month period.
