## I. PURPOSE AND OBJECTIVE:

The purpose of this procedure is to identify how to view Beaumont Courier Specimen documentation utilizing the bar codes on requisitions. The bar codes are scanned by couriers when picked up and delivered to the performing laboratory. The couriers identify the number of tubes and tube type for that requisition. This quick guide will walk the user through the pulling of the courier report in Soft Express along with identifying the appropriate fields to be reviewed.

# **II. PROCEDURE:**

- A. Log into SoftExpress: from the desktop and click on the "Reports" tab
- B. Click on the icon "Customized" reports
- C. Click on the "Tubes for Requisitions" report
- D. Click on "View"
- E. Scan or key in the requisition number located underneath the requisition barcode. \*\*Remember, if you do not have the requisition in front of you or it has not yet been imaged, you can review this information in the Outeach ID field in requisition entry. This can be copied and pasted into the requisition number field in Soft Express.
