1. Corewell Health Updates – East

- A 3% general pay increase for all eligible Corewell Health East care delivery team members will become effective Sunday, March 24, and will be visible in your pay slips on Friday, April 12.
- b. There will also be a matching retirement plan contribution to those who participated in the legacy Beaumont Health 403 (b) plan in 2023. b. Newborn wrist bands

i. The new shipment of baby bands with the N# only have 4 digits in the number. There are still some the 5 number bands left so please be aware that both bands are acceptable.

c. DTT Testing

- i. Here is a summary of when we send for DTT testing:
 - 1. The first time a Darzalex patient reactive at 60-minute No LISS comes in we send to make sure there are no underlying antibodies since rule outs could not be performed.
 - 2. Repeat DTT screen testing would be done if any of these occur:
 - a. The 60-minute No LISS surgiscreen strengths increase.
 - b. Unexpected stronger crossmatch that could signal the formation of a new antibody.
 - c. Every 90 days from the last time it was performed.
 - 3. DTT crossmatches:
 - a. Perform when it is not possible to obtain phenotypically matched units.
 - b. If a patient has a TWTI or WarmIgG, then we must do DTT treated crossmatches even if we have phenotypically matched units since we can't provide phenotypically matched units for a TWTI/Warm IgG. In this case, Royal Oak does not have to repeat the DTT screen unless any criteria from the first set of bullet points are met.
 - 4. NOTE:
 - When sending samples to Royal Oak for DTT testing, we send a BMISC that they can do their ABID from, and an aliquot for the TS that they can use for DTT crossmatches if indicated.
 - b. Royal Oak will keep the BMISC sample and an aliquot of the TS.
 - **c.** Royal Oak will document the DTT crossmatches as an internal comment under the crossmatch for the unit; they will not result the crossmatch.
 - **d.** When they send the units back, we have to do a gel crossmatch using the TS sample that we retained. This will be incompatible, so the least incompatible form does still need to be documented and the RN/Doctor does still need to be notified that the units are not compatible.
