New Policies, Procedures, Alerts or Reminders

- a) Under filled EDTA samples with delta check MCV should NOT be released. They should be reported as unsuitable and/or underfilled.
- b) ESR results not transmitting to Cerner as of the 6th May, Pathology IT investigating. Use the manual worksheet until the issue is resolved.
- c) Please unpack deliveries when they are received, do not leave unopened packages on seniors desk. Document lot number and expiry date of products and leave just the delivery slip on seniors desk.
- d) Reminder when using IH500 for phenotyping that results can be compromised by DAT positive cells regardless of the fractionation. Appropriate phenotype testing must be done in tube.
- e) When Pharmacy drop off the release cards for the Sclg products Hizentra, Xembify or Cuvitru, can we please complete these orders as soon as possible. Any issues need to be brought to the attention of Andrew or the 2IC for follow up ASAP

Just to note, for this group of patients prior collections there is an urgent request of CD4/8 in AM to be run on Aquios analyser (these samples are still day-booked as CD4/8)
- i) Irradiated packed red cells orders with now be accompanied by an irradiated check for all patients who do not have an irradiated comment in the transfusion requirements. This test code will be used to capture patients who may need irradiated units that we have not previously been notified about.
