Sheath/Rinse Missing Linear Barcode

Reason for Customer Notification

Siemens Healthcare Diagnostics has confirmed the linear barcode is missing from the label of the ADVIA®120/ ADVIA®2120/ ADVIA®2120i Sheath/Rinse cubitainers for the lots listed in Table 1.

There are two barcodes required on each cubitainer. The barcode required for automatic entry of the lot number and expiration date was not placed on the cubitainer during manufacturing of these lots.

Both the 20L (SMN 10312272/REF 01554628) and 10L (SMN 10316869 /REF: 02337140) configurations are impacted.

Risk to Health

The potential exists for a minimal delay in testing during manual entry of lot and expiration date information. The risk to health is negligible.

Actions to be taken by the Customer

For the products listed in Table 1, you may continue to use these products by performing the following steps:

Refer to the instructions in the Operator Guide (Section "Replacing the Sheath/Rinse") on how to manually enter this information into the system.

- At the Logs menu, select the Reagent tab
- Select Reagent Installation
- For each new reagent lot number enter in the Expiration Date and Lot #
