

1) LIS Cancellations:

- Refer to your LIS procedures and keep your LIS tips. Referring to these will solve most of your problems. They are useful tools and can be found in the sharepoint, MTS and LIS binders.
- April will no longer fix our problems if we have to tools to do so ourselves. If you can't find the appropriate_information see your MLT II.

2) Erroneously Resulted Tests:

- Any result that has been released and needs correction must be fixed by a MLT. MLA's do not have security access to amend results.
- The procedure requires more than just cancelling the test in order entry.
 Refer to procedure. This procedure is how we can ensure the corrections are posted to the EMR and Health Net Viewer
- 3) When unloading the centrifuge please remove all of the balance tubes.
