1. Inventory Management

- If recording temperature please have a look at the chart to ensure temp matches. If it doesn't arm can be re-calibrated instructions are under chart.

4. Cancellation of Lab tests - Discussion

- Consensus of Stanton lab employees is not to phone cancellations that the cancel/reject report go to the ordering physician and physician can decide whether patient should be recollected or not.

- Jen to take this to lab leaders meeting so that a nthssa wide process is hammered out
- Jen to forward LIS procedure for cancellation to everyone in the meantime.

- They are not traceable
- Don't have to encrypt patient info because they are internal
