## 1. Istat - Gas testing with CG4 cartridges

- We will be discontinuing testing of gases on the IStat using CG4 cartridges.
- Gas testing will be performed on ABL 800 with the 90's as the backup

### 2. Calling Critical Results to the Personal Communication Devices
