1. Accel TB Wipes:

- Laura S wanted to make sure that everyone knew where they were being stored.
- They are being stored in the grey cabinet in the TB ante room.

2. N390 Cards:

- QC organisms are the same as the old cards.
- Moses, Solomon and David have had a chance to use the cards and have not found any issues.
- Amikacin is not on the new card. It needs to be reported if Gent/Tobra are resistant but it is the third line. Don't worry about sending this to DynaLIFE unless the organism is very resistant and the Dr. might need to use this drug.
- Fosfomycin is on the card but it is not validated for use. If the ASTM says to report this drug, we do need to send it to DynaLIFE since it is a second line drug.

3. Ordering:

- The hospital has changed the ordering system they are using to SAM.
- This is why I pre-ordered so much stock so that we don't run out during the transition period.
- Moses and David will be going for training downtown on February 18 to also learn how to order products.

4. Water orders:
