1	Urinalysis samples update	RR	 Although urine samples are not STATs, but process them as soon as possible. Some concerns are due to proliferation of bacteria, change in urine pH, and possible dissolution of some sediment. Referred urine samples from HR, FS, and Inuvik – you have 48 hours to complete the urinalysis. Please check the collection dates of the urines. Once a urine had been spun, read it right away. We will reassess the workflow in 6 weeks' time. 		
2	STAT priority in Chem	RR	 Let's try to organize our lab especially when dealing with STAT samples in Chem. Please prioritize the STAT samples and we have 48 hours to complete the routine (RT) samples. Suggestion: Stop running Chemistry RT samples around 2130h-2200h to have time to finish other lab staff such as shutting down the instrument, review your pending report, and disinfection of the bench. 		
3	Lab jacket	EC	• Elwood will chat to everyone regarding the lab jacket info and price.		
4	Bench communication book	RR	 For each bench communication log book, please write the important things to know, and not necessarily to write the full details to save your time. Example: Hema – new lot Low Fib (N07) in use.

6	Pending Report (PR) issue	EA	 Check the PR frequently to monitor all referred samples for the date. Any missing samples must be communicated to the referring clinics via SoftComm. If you're running out of time to check the PR, check the sample tubes. 	
7	Samples from HR, FS, or IN	RR	• We will ask Elwood to send a note to the referring clinics if they can separate STATs and RTs to save time and avoid confusion when shipping their samples in our lab.	
8	Entering lots in TQC	EA	When you open a lot, please open it in TQC as wellIf you don't know how to do it, please ask.	
9	Biohazard carton boxes	EA	 It is everyone's responsibility to change the biohazard carton box in Chem, Hema/US, or BB benches. The maximum weight is 16 kgs. Don't let it be full. Sometimes you need to swap Chem or Hema with BB box as BB box is usually becoming heavier. 	
10	BB boxes	EA	Empty the BB boxesTake out the frozen or gel packs	


