#### 5. VITEK 99%:

- Just because you get 99% on the VITEK, it doesn't mean it is 99% correct
- The VITEK measures biochemical tests and then uses a database to find a match. It could give you an organism, but it might not be the right one
- If you get an ID of something that is very rare or you have never heard of, make sure you research the organism and make sure it matches what you have. Do any spot tests available first to make sure everything matches
