Important update to COVID-19 Employee Policy

Colleagues,

COVID-19 is here to stay — but with the availability of testing, vaccines and treatments, risk of severe illness and death is much lower than early in the pandemic. Updated guidance from the CDC and public health authorities signals we can continue to safely adjust our COVID-19 policies at Quest.

Effective October 4, 2022, we will discontinue our COVID-19 Pay Policy, which provides pay for time off taken due to COVID-19. We're making this change after carefully reviewing COVID-19 Pay usage and benchmarking other high-performing healthcare companies.

Keep in mind:

- Colleagues who need to take time off can use existing time off and leave policies, including
 accrued PTO Health and PTO, if needed. Please visit the HR Portal to review our paid time off
 plans.
- Employees who are out of work for an approved COVID-19-related reason as of October 3, 2022, will continue to receive COVID-19 Pay per the policy that was in place on the first day they were out. There will be a one-time manual adjustment for these impacted employees.
- Employees living in certain jurisdictions may be eligible to receive compensation if they have to
 miss work due to COVID-19 based on state and local laws and for as long as such laws remain in
 place. As of September 1, 2022, the following jurisdictions have COVID-19 pay laws in place:
 - o California
 - o Colorado
 - o Nevada
 - o New York
 - o Philadelphia, PA

Our Safely Working Together committee continues to monitor pandemic trends and revisits our policies as needed.

Thank you for your agility as we continue to keep pace with COVID-19 guidance. I hope you were able to enjoy Labor Day weekend and refresh yourself mentally and physically.
