Credit Replace Results (New): When a test is credited for a specific reason (i.e. QNS, WRONG, etc.), this will allow the tech to enter the comment once instead of having to enter under each test.

Credit Remove (New)-Only Results at Order Entry: This feature will now allow everyone the opportunity to cancel tests that were part of a package (i.e. CBCD), Microbiology cultures and Blood Bank samples that do not have results.
