## Hazard Communication Standard – Precautionary Statements

#### **Prevention**

Wash (parts of body) thoroughly after handling.

Do not eat, drink or smoke when using this product.

Do not get in eyes, on skin, or on clothing.

Wear protective gloves/protective clothing (specific type).

Do not breathe dust/fume/gas/mist/ vapors/spray (specific conditions).

Use only outdoors or in a well-ventilated area.

In case of inadequate ventilation wear respiratory protection (must explain what type of ventilation would be adequate for safe use)(specific type of respiratory protection).

Avoid breathing dust/fume/gas/mist/ vapors/spray (specific conditions).

Do not breathe dusts or mists.

Wear protective gloves/protective clothing/eye protection/face protection (specific type).

Wear protective gloves (specific type).

Wear eye protection/face protection (specific type).

Contaminated work clothing must not be allowed out of the workplace.

Obtain special instructions before use.

Do not handle until all safety precautions have been read and understood.

Avoid contact during pregnancy/while nursing.

Wear personal protective equipment/face protection (specific type).

Keep away from heat/sparks/open flames/hot surfaces (specific ignition source(s)). - No smoking.

Keep wetted with (specific material).

Ground/bond container and receiving equipment.

Do not subject to grinding/shock/(specific type of rough handling)/friction.

Wear face protection (specific type).

Do not spray on an open flame or other ignition source.

Pressurized container: Do not pierce or burn, even after use.

Keep/Store away from clothing/(specific incompatible materials)/combustible materials.

Keep reduction valves/valves and fittings free from oil and grease.

Wear cold insulating gloves/face shield/eye protection.

Keep container tightly closed.

Use explosion-proof electrical/ventilating/lighting/(specific equipment)/equipment.

Use only non-sparking tools.

Take precautionary measures against static discharge.

Wear protective gloves/eye protection/face protection (specific type).

Keep away from flames and hot surfaces. - No smoking.

Keep only in original container.

Do not allow contact with air.

Keep cool. Protect from sunlight.

Do not allow contact with water.

Handle under inert gas. Protect from moisture.

Keep away from heat.

Take any precaution to avoid mixing with combustibles/(specific incompatible materials).

Wear fire/flame resistant/retardant clothing.

#### Response

If swallowed: Immediately call a poison center/doctor/(appropriate source of emergency medical advice).

Specific treatment (see (reference to supplemental first aid instruction) on this label).

Rinse mouth.

Wash with plenty of water/(specific cleansing agent if appropriate, or recommended alternative agent in exceptional cases if water is clearly inappropriate).

Take off immediately all contaminated clothing and wash it before reuse.

If on skin: Wash with plenty of water/(specific cleansing agent if appropriate, or recommended alternative agent in exceptional cases if water is clearly inappropriate).

Call a poison center/doctor/(appropriate source of emergency medical advice)/if you feel unwell.

Take off contaminated clothing and wash it before reuse.

If inhaled: Remove person to fresh air and keep comfortable for breathing.

Immediately call a poison center/doctor/(appropriate source of emergency medical advice).

Specific treatment is urgent (see (reference to supplemental first aid instruction) on this label).

If swallowed: Rinse mouth. Do NOT induce vomiting.

If on skin (or hair): Take off immediately all contaminated clothing. Rinse skin with water/shower.

Wash contaminated clothing before reuse.

If in eyes: Rinse cautiously with water for several minutes. Remove contact lenses, if present and easy to do. Continue rinsing.

If skin irritation occurs: Get medical advice/attention.

If eye irritation persists: Get medical advice/attention.

If inhaled: If breathing is difficult, remove person to fresh air and keep comfortable for breathing.

If experiencing respiratory symptoms: Call a poison center/doctor/(appropriate source of emergency medical advice).

If on skin: Wash with plenty of water/(specific cleansing agent if appropriate, or recommended alternative agent in exceptional cases if water is clearly inappropriate).

If skin irritation or rash occurs: Get medical advice/attention.

If exposed or concerned: Get medical advice/attention.

If exposed: Call a poison center/doctor/(appropriate source of emergency medical advice).

If exposed or concerned: Call a poison center/doctor/(appropriate source of emergency medical advice).

Get medical advice/attention if you feel unwell.

Do NOT induce vomiting.

Explosion risk in case of fire.

Do NOT fight fire when fire reaches explosives.

Evacuate area.

In case of fire: evacuate area.

Fight fire with normal precautions from a reasonable distance.

Leaking gas fire: Do not extinguish, unless leak can be stopped safely.

Eliminate all ignition sources if safe to do so.

In case of fire: Stop leak if safe to do so.

Thaw frosted parts with lukewarm water. Do not rub affected area.

Get immediate medical advice/attention.

In case of fire: Use (specific media) to extinguish.

In case of fire: Evacuate area. Fight fire remotely due to the risk of explosion.

If on skin: Immerse in cool water/wrap with wet bandages.

Brush off loose particles from skin. Immerse in cool water/wrap in wet bandages.

If on clothing: Rinse immediately contaminated clothing and skin with plenty of water before removing clothes.

In case of major fire and large quantities: Evacuate area. Fight fire remotely due to the risk of explosion.

Absorb spillage to prevent material damage.

# Hazard Communication Standard - Precautionary Statements

### **Storage**

Store locked up.

Store in a well-ventilated place. Keep container tightly closed.

Store (in accordance with local/regional/national/international regulations (to be specified)).

Store in well-ventilated place.

Protect from sunlight. Do not expose to temperatures exceeding 50 °C/122 °F.

Protect from sunlight. Store in a well-ventilated place.

Store in a well-ventilated place. Keep cool.

Store at temperatures not exceeding (specific temperature) °C/(specific temperature) °F.

Store away from other materials.

Store contents under (specific liquid or inert gas).

Maintain air gap between stacks/pallets.

Store bulk masses greater than (specific mass) kg/(specific mass) lbs. at temperatures not exceeding (specific temperature) °C/(specific temperature) °F.

Store in a dry place.

Store in a closed container.

Store at temperatures not exceeding (specific temperature) °C/(specific temperature) °F. Keep cool.

Protect from sunlight.

Store in corrosive resistant/(specific compatible material) container with a resistant inner liner.
