CONTENTS OF A SAFETY DATA SHEET

(Section 1 of 3)

Purpose: To comply with the Hazardous Substances Training and Information Act set forth in Title 8, Sections 6360-6399.9 of the California Labor Code.

Safety Data Sheet Definition and Description of Contents:

A Safety Data Sheet can be defined as a document which provides detailed chemical, physical and hazard information for a particular hazardous substance or mixture. This information includes: 16 sections:

1. Identification: Product identifier & any other common names or synonyms by which the substance is known. Name & address of manufacturer, importer, or other responsible party and emergency phone number. Recommended use of the chemical and any restrictions on use.
2. Hazard (s) Identification: Hazard classification of the chemical, signal word, hazard statement(s), pictograms, precautionary statements, description of hazards not otherwise classified, percentage of mixture with unknown acute toxicity.
3. Composition/Information on Ingredients.
4. First Aid Measures
5. Fire-Fighting Measures
6. Accidental Release Measures
7. Handling and Storage
8. Exposure Controls/Personal Protection
9. Physical and Chemical Properties
10. Stability and Reactivity
11. Toxicological Information
12. Ecological Information (non-mandatory)
13. Disposable Considerations (non-mandatory)
14. Transport Information (non-mandatory)
15. Regulatory Information (non-mandatory)
16. Other information

LEGAL RIGHTS OF THE EMPLOYEE

(Section 2 of 3)

Purpose: To inform employees of their rights under chapter 6398 of the California Labor Code.

Rights of the Employee:

1. Upon request, a copy of a Safety Data Sheet/s for a substance or substances used in the workplace shall be made available to an employee, collective bargaining representative, or the employee's physician, in a timely and reasonable basis.
2. Employers shall furnish employees who may be exposed to a hazardous substance with information on the contents of the Safety Data Sheet for the hazardous substance and/or equivalent information, either in written form or through training programs, which may be generic to the extent appropriate and related to the job being performed.
3. The employee must be advised that he/she cannot be discharged or subjected to any discrimination due to exercise of the rights afforded to them under the Hazardous Substance Information and Training Act.
4. Each department using hazardous substances must keep Safety Data Sheets in a prominent place within their department.
5. When an employer receives a new or revised Safety Data Sheet, such information shall be provided to employees on a timely basis, not to exceed 30 days after receipt.
