Purpose of Product:	DeNovo <sup>®</sup> Infant Heel Warmer are intended "For Use by hospital, Ambulatory Surgery Staff, Outpatient Clinics, for warming of infant's heels prior to drawing blood for sampling or general analysis or therapeutic purposes".

Key specifications of product:	DeNovo® Heel Warming Pouches are a see-through package constructed of 1oz /A/606a BONA/2 mill LLDPE, heat-sealed together forming a pouch. Inside the Pouch is a Stainless Steel .75 +/01 diameter disc and "0.08 to 1.8 oz" of a branded solution (See Compound section of this document for branded solution details)

Shipping Conditions & Requirements:	<ul> <li>a) While DeNovo® products "(infant heel heaters) are in transit they must be kept on their original Pallet, wrapped with plastic shrink film.</li> <li>b) Do not double stack and keep in its closed cardboard boxes.</li> <li>c) Do not make any sudden movements, do not drop the pallet.</li> <li>d) Should be maintained in a clean, dry and well-ventilated areas at all times.</li> <li>e) Product must be protected from direct sunlight, UV light sources and excessive moisture.</li> <li>f) Shipment must be kept as close to room temperature as possible, avoid freezing temperature under 50°F and Hot Temperatures above 78°F.</li> </ul>	
Storage Conditions:	DeNovo® recommends that infant heel warmers are kept in the original, closed transport carton or inside a closed cabinet to its point of use. Product should be stored in a dry, clean and well-ventilated environment and protected from direct sunlight, UV light sources and excessive moisture. Product must be stored as close to what is known as "room temperature" (between 50°F and 78°F) as possible.	
Packaging Conditions:	Packing conditions should be able to protect the Heel Warmer from UV rays to its point of use.	
Shelf Life:	The shelf life is time related and not event related. It is recommended that the products are put to their end use within 2 years of manufacture. The recommended "Expiration" date, and the Lot number are printed on the product inner and outer carton Box. Also, the date of manufacture is printed on the sealed area of the left front (printed side) of the bag.

	Instructions for Using the Product
Description of Use (s): (Intended Use)	DeNovo <sup>®</sup> Infant heel warmers are intended to aid in the drawing of blood for sampling or general analysis. If indicated by a physician, this product can be used as a therapeutic component to provide warmth to the patient.
Preparation for Use:	<ol> <li>Confirm product date code is within Manufacturer expiration date code specifications. (Maximum Two (2) years from manufactured date)</li> <li>Ensure that pouch physical conditions (pouch seal), and contents looks fine.</li> <li>Before activation, massage pouch to bring solution close to manufacturer's activation temperature recommendations 75-78 °F (23.8 -25.6 °C).</li> </ol>

Steps for Use of Product:	<ol> <li>Inside the pouch locate a round metal disc and grasp with thumb and forefingers. Confirm that recommended activation set temperature (Start Temperature) is within +/- 75 °F (23.8 °C) +/- 1°F.</li> <li>Flex the disc rapidly until pouch liquid transform to crystals and pouch begins to warm up.</li> <li>Massage the bag for 30 seconds to increase the product temperature, distribute the heat evenly and soften the bag. Insure that the product does not feel too warm prior to application.</li> <li>Apply the pouch Non-Printed side to the patient.</li> <li>To secure the bag, peel the paper covering the adhesive part of the strap and adhere it to the opposite side of the bag.</li> <li>Monitor the patient's skin occasionally to see if the skin is reddened.</li> <li>Notes:         <ul> <li>a) Do Not apply the adhesive part of the strap to infant skin.</li> <li>b) Do not apply to unattended infants.</li> <li>c) Dispectable product = Single Use Only = ***DO NOT PEUSE***</li> </ul> </li> </ol>
